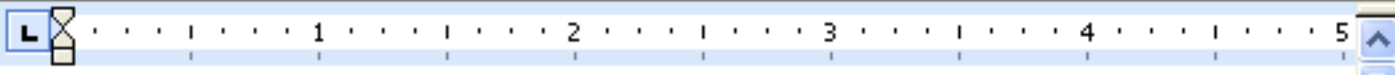
EBriefPro Composer then places the transcript or excerpt, in its original and PDF file formats, into this new folder. This structure allows your ebrief and all linked documents to be copied virtually anywhere while ensuring that the hyperlinks will still work.

The file names reflect the original file names and the page range containing your selection.

Including the original excerpt makes it easy to create different versions of the PDF.

If the reader holds down the Control key while clicking the link, the hyperlinked document will open up in its own window.

The ebrief can be converted to a PDF or HTML. With the correct conversion settings, the hyperlinks will still function.

After the ebrief is converted to PDF or HTML, a single click will open a hyperlinked document.



Here, the hyperlinked document - a PDF version of the caption page and the page containing the quote - has been opened in a PDF reader by clicking the hyperlink in the ebrief.
